CONSIGNMENT AGREEMENT

THIS AGREEMENT, made and entered into this _____ day of _____, 20____, by and between _____ “consignor” and “Consignments,” and/or “consignee.”

Please circle choice. Consignor accepts: 40% (CHECK) or 50% (STORE CREDIT).

WHEREAS, the consignor wishes to sell the item(s) listed in this consignment agreement, and “Consignments” agrees to facilitate the sale of said items. “Consignments,” at the sole discretion of their staff members, will price and negotiate suggested prices to attempt to sell the inventory for a period of **ninety (90) days**. After sixty (60) days of the 90 day term, “Consignments” will **reduce** said prices by **TWENTY FIVE PERCENT (25%)**. JEWELRY, NOT TYPICALLY DISCOUNTED, CARRIES A TERM OF 180 DAYS.

CONDITIONS OF SALE:

1. Consignor agrees to consign and TRACK his/her inventory for 90 days from the **date the items are priced**. Jewelry consignments remain for 180 days (187 day term before expiration). Consignor agrees to pick up unsold inventory within 7 days of the expiration date that the item was initially priced. If Consignor **CHOOSES NOT TO** pick up unsold items **FOR ANY REASON** during the 7 day grace period, the consignor does hereby “gift” “Consignments” all unsold inventory in this contract by NOT picking up during the 7 day period provided. “Consignments” will then dispose of said inventory as is most convenient. **THERE WILL BE NO OTHER NOTICE GIVEN TO CONSIGNOR** about the expiration of the 90 days. **Consignor is solely responsible for keeping up with the term of this contract, when to call & remove said inventory. CONSIGNOR INITIALS _____**
2. The Consignor is responsible for any and all insurance coverage on said consigned items. “Consignments” assumes NO liability for damage, pilferage, fire, theft or insurance coverage of any kind.
3. “Consignments” shall **price and negotiate** to attempt to sell the consigned items for a commission to be paid to “Consignments” of 60% of the selling price OR 50% IF Consignor accepts 50% in store credit.
4. Only when items are sold, “Consignments” will supply a monthly sales record to the Consignor along with a check for the items that were sold during said month. The sales record and the check will be available by the 10th day of the following month. Mail check for \$1.00 fee _____ SELF PICK-UP _____
5. Consignor is bound to this contract once signed. Items listed in the inventory may not be removed without written consent from “Consignments” during the 97 days. Consignor agrees to pay a commission of 50% of the sale price at the time of removal of said item, if removed prior to the expiration of the date the item was priced.
6. **PROMPT REMOVAL OF CONSIGNED ITEMS:** “Consignments” or “Consignee” may at any time cancel this contract upon forty-eight (48) hours prior notice to the consignor by phone or email. The consignor agrees to remove their consigned items within 48 hours after the date of notice of cancellation set forth above. Should the consignor not remove merchandise within 48 hours of notice, consignor agrees to pay a storage fee of **\$50.00** per day (24 hrs), until the consigned items are removed. Removal period will only be granted for 5 days after notice, at which time, “Consignments” will consider merchandise abandoned and will dispose of said merchandise however is most convenient.
